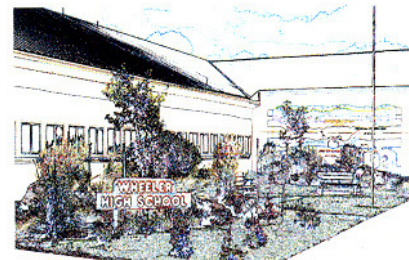

## Internet Access Use Agreement Fossil Charter School

To be able to connect to the Internet, students at Wheeler High School and Fossil Elementary are being given a wonderful opportunity to communicate electronically with people around the world and to research subjects from a vast array of resources. With opportunity comes responsibility. Before being allowed to access the Internet, students will need to be trained in Internet navigation techniques to make the most of their online time. They and their parents must agree to the following rules for acceptable use:

1. Use of the Internet will be solely for purposes related to school curriculum, for research and communication relevant to courses offered in Fossil School District.
2. Use of the Internet for profit or personal business is not allowed.
3. Users will not modify files or use passwords belonging to others. They will respect the right to privacy of other users. However, as the legal licensee, the district reserves the right to inspection of all files at any time.
4. Users will respect the hardware and software provided and will not abuse it in any way.
5. Users will respect individuals and not use discriminatory or offensive remarks, profane or obscene language in any form of communication, including, but not limited to e-mail, v-mail, IRC, Instant Messenger, or user net group postings.
6. Users will not infringe on the copyrights of programs or writers' materials acquired through Internet sources or violate any local, state or federal statutes.
7. Users will not access, upload, download or distribute pornographic, obscene, sexually explicit or sexually suggestive material.
8. Users will not participate in IRC or instate messaging without the knowledge and permission of their teacher. Such activity must be related to the curriculum.
9. The computers, all hardware, software, and licenses are the property of Fossil School District 21J and subject to inspection by the District at any time.

**Access to the Internet is a privilege, which can be revoked at the discretion of the Superintendent.**

Any student found in violation of any of these rules will be subject to a six-month suspension of Internet privileges. A second offense will result in a one-year suspension of Internet privileges.
